## PRESENTATIONS / REPORTS:

**Construction Update:** Joe Hayes or Ehmet Hayes Architects reported on continued completion activities at the new Transportation and Maintenance Office.

### The GCHS Admin Team Report:

Mr. Clay Mattingly, new principal at Grant County High School introduced himself and his team to the Board. He reported that much of their emphasis thus far has been building culture. Their new hashtag, #Buildthetribe, can be expanded in many ways to focus on providing: safety, positivity, a strong foundation, success (defined in a variety of ways), pride, connectivity, and doing something that matters.

- R Reach for the same goals
- I Interact with one another
- B Be accountable to one another
- E Empower one another.

Instructional Focus will include: Focus on core beliefs and values, building capacity of new staff members, walkthrough feedback via google forms and analysis at leadership meetings Organizational Focus will include: Weekly leadership meetings with focus on empowering staff; safety and organizational reviews with focus on becoming more effective and efficient; living calendar and team drives; high expectations for students and staff.

Mr. Mattingly reported that Laura Smith had been selected as the new Eagle Creek Academy Program Director. Mr. Butler gave an update on students taking advantage of a variety of Career and Tech internship opportunities.

## **BOARD DISCUSSIONS AND ACTIONS:**

Fundraisers were approved for SES and MCE's PTOs.

**District Funding Assurances** were approved -- documenting that Grant County Schools is in compliance with the various requirements of named state and federal funding sources.

Additional ARC Chairpersons were approved, adding Jacob Brown and Lindsey Smith at GCMS; Larry Butler and Josh Powers at GCHS; and Emma Harris from the District Office.

The 2019 Working Budget was approved.

The creation of a position for District Wide Intervention Specialist to work with identified 4<sup>th</sup> and 5<sup>th</sup> graders (using Read 180 Program) was approved. Funds will come from carry-over ESS funds, Title I funds, and school SBDM monies.

Use of the GCHS Course Codes at GCMS was approved.

Property at 505 South Main, Williamstown, KY (the former T&M building) was declared as surplus property. This allows the Board to begin the process of making it available for sale (appraisal, etc). It will continue to serve as a satellite staging area for buses serving the south end of the county until such time as the property is disposed.

## **SUPERINTENDENT REPORT:**

Mr. Morgan reported:

- Grant County and Williamstown Schools will host and present at the upcoming GC Chamber
  of Commerce Breakfast September 17. Mr. Morgan and Misty Middleton, Wmstown Supt.,
  will do their "state of the schools" report to the Chamber together.
- Profile of a Graduate work will begin at a meeting held Monday, October 8, 2018, 5:00 6:30 pm. Board member input is desired. Debbie Rogers and Bryan Slaughter volunteered to work in this capacity.

## **BOARD MEMBER REPORTS:**

Debbie Rogers, whose daughter was in the lobby during the recent Fifth Third Center shooting in Cincinnati, questioned regarding our **cell phone policy at GCMS** which requires that phones be left in lockers, in light of a parent's need to communicate with their children during a real crisis. Mr. Morgan promised to bring her concern to the GCMS SBDM.

Upon the recommendation of Gene Nelson, the Board approved a \$2000 stipend for Linda Justice for her service as Board Secretary July 1, 2018-June 30, 2019.

Lisa Smith has had parent inquiries regarding our **head lice policy**...specifically the lack of communication regarding when it is appropriate to be watching and/or taking extra precautions. Mr. Morgan explained that this is a tricky issue, with practices having moved from strict no-nit policies years ago to less exclusion now. He will solicit information from KSBA regarding ways other districts may be handling this issue.

Bryan Slaughter shared regarding an opportunity the district has to receive **paving materials** free of charge. He also expressed concern regarding a list he had created of known, needed **facility improvements**, and related costs.
