Our attendance goal of 95%. For behavior, we utilize the Dojo App to measure three schoolwide behaviors/focus areas. Our students have ownership of their body, words and belongings. Based on a point system on the dojo app, students are able to attend a schoolwide quarterly reward if they are at or above 80% for the three focus areas combined.
