### 2024-2025 Phase Three: Comprehensive District Improvement Plan

#### Rationale

District improvement efforts are a collaborative process involving multiple stakeholders. During the improvement planning process, leaders focus on priority needs, district funding, and closing achievement gaps between identified subgroups of students. When implemented with fidelity, the Comprehensive District Improvement Plan (CDIP) cultivates an environment that promotes student growth and achievement.

While the focus of continuous improvement is student performance, the work must be guided by the aspects of teaching and learning that affect performance. An effective improvement process should address the contributing factors creating the learning environment (inputs) and the performance data (outcomes).

#### **Operational Definitions**

**Goal:** Long-term three- to five-year targets based on the required school level goals. Elementary/ middle schools must have goals for state assessment results in reading and mathematics, state assessment results in science, social studies and writing, achievement gap, English learner progress, and quality of school climate and safety. High schools must have goals for state assessment results in reading and mathematics, state assessment results in science, social studies and writing, achievement gap, English learner progress, quality of school climate and safety, postsecondary readiness, and graduation rate. Long-term targets should be informed by the Needs Assessment for Schools.

**Objective:** Short-term target to be attained by the end of the current academic year. Objectives should address state assessment results and/or aligned formative assessments. There can be multiple objectives for each goal.

**Strategy:** An approach to systematically address the process, practice, or condition that the school will focus its efforts upon, as identified in the Needs Assessment for Schools, in order to reach its goals or objectives. There can be multiple strategies for each objective. The strategy can be based upon Kentucky's six (6) Key Core Work Processes listed below or another established improvement approach (i.e. Six Sigma, Shipley, Baldridge, etc.).

**Key Core Work Processes:** A series of processes identified by the Kentucky Department of Education that involve the majority of an organization's workforce and relate to its core competencies. These are the factors that determine an organization's success and help it prioritize areas for growth.

KCWP 2: Design and Deliver Instruction

KCWP 3: Design and Deliver Assessment Literacy

KCWP 4: Review, Analyze and Apply Data Results

KCWP 5: Design, Align and Deliver Support

Our district is primarily maintaining our existing initiatives - high-quality instruction, closing the gap, and a safe and healthy culture. We believe consistency is essential and change takes time. Our main objectives for high-quality instruction center on



both required components and district priorities. We are focusing on the full implementation PLC model. We are also working to improve our instructional protocol to be more inquiry-based. We currently have HQIRs at the elementary level (math and reading), middle school level (science), and high school level (science, math). Finally, our required components such as closing the gap (students with IEPs), safety, and EL have been included. On a positive note, two of our schools exited TSI status in the last accountability year.

For a safe and healthy culture, we are working to ensure PBIS is implemented in all schools, including Tier 2 and 3 behavior intervention. We will continue our work with our Deeper Learning Plan to ensure that all students in grades K-12 engage in and can articulate the SUCCEED criteria, our district profile of a learner model. We will continue to focus on supporting our schools to improve student attendance. Finally, we are fortunate to have SROs at all 6 of our schools and work will continue to center on ensuring their effectiveness.

#### District Objectives:

- Grant County Schools will fully implement the PLC process by the end of the 2024-2025 school year.
- Grant County Schools will use the Grant County Schools Instructional Protocol to ensure equitable high-quality instruction in all classrooms by the end of the 2024-2025 school year.
- Grant County Schools will adopt and deploy high-quality instructional resources to ensure student growth in reading, math, and science by the end of the 2024-2025 school year.
- Grant County Schools will implement a high-quality teacher induction program to retain teachers by the end of the 2024-2025 school year.
- Grant County Schools will provide effective support for EL/Multilingual learners by the end of the 2024-2025 school year.
- Grant County Schools will provide effective supports for Special Education students in TSI schools by the end of the 2024-2025 school year.
- Grant County Schools will fully implement PBIS plans focused on academic behaviors by the end of the 2024-2025 school year.
- Grant County Schools will implement SUCCEED plan (Profile of a Learner) to ensure students graduate prepared for life after high school by the end of the 2024-2025 school year.
- Grant County Schools will effectively implement the Grant County Schools Attendance Protocol by the end of the 2024 2025 school year.
- Grant County Schools will implement a highly effective safety plan by the end of the 2024-2025 school year.
