Dry Ridge Elementary, a proud part of the Grant County School District in Dry Ridge, KY that sits right off of I-75. The current enrollment at DRE is 425 students in grades PK - 5. 15.8% of our students receive Special Education Services and we are above 70% in free/reduced lunch count. A unique feature about DRE is the fact that we house 4 of our District's SPED units. We have 1 autism unit and 2 FMD units. Having these units in the building provides an opportunity for our students to gain perspective and to work collaboratively with those students who may face different barriers that they do. This creates more a more empathetic perspective amongst our students and builds an inclusive attitude amongst our students, teachers, staff members, and parents. At Dry Ridge Elementary we are continually looking for opportunities to connect with our community and engage with our parents and our community members.

Our PTT (Parents and Teachers Together) along with our Family Resource Youth Service Center are always collaborating on unique ways for our students, parents, and teachers can engage with each other and be part of the school community. Dry Ridge Elementary is an MTSS (Multi-Tier System of Support) school and focuses on our Cardinals of Character traits in our PBIS. We are very proud of the work that our teachers, staff, students, parents, and community members put in to help grow our Cardinals to be the future leaders of Grant County!

Our key focus will continue to be on literacy and numeracy skills for all students. To reach this goal we are working to equip our teachers with high-quality professional development in the areas of strategies for teaching math and reading, especially in phonics and phonemic awareness. We believe in building a strong foundation in the K-2 grade levels that will launch our students forward in Grades 3-5. Our classrooms are structured to reflect the Grant County Model of co-teaching to help deliver high-quality large group and small group instruction to all students in the classroom. We have set up our building Guiding Coalition as well as vertical teams in both Reading and Math to greatly improve teacher collaboration around the teaching of Reading and Math and the review of data and our action plan. DRE will continue to use common assessments in reading and math along with the MAP assessment to track student data. These assessments provide the rigor and focus on common core standards needed to propel our students to the highest levels of learning.
