Dear Parents/Guardians,

Since the district math challenge began in January, our fourth-grade students have been working extremely hard to master their multiplication facts. We are so proud of their efforts and have begun to prepare for their special reward in May.

Students selected their choice for the reward they desired to work for in May, either a trip to Defy indoor trampoline park or to Cinemark Florence 14 movie theater. If your student has selected Defy as their reward, it is required to have a completed waiver before participating in the 90-minute jumping session. We would like to go ahead and have all parents/guardians complete the waiver for their student so this is on file and does not prevent your student from participating in their reward on May 20th.

If your student has selected Defy as their reward for the May 20th field trip, please follow the directions below to complete the waiver which will permit him/her to participate in the 90-minute jumping session.

Please note: This waiver must be completed online before your student attends the field trip. Please take a few minutes to go ahead and complete this waiver. We ask that you complete this waiver by May 1st to assist us in preparations for this day of fun!

STEP 1: Go to the Florence Defy website: <u>https://defy.com/defy-florence-ky/</u>

STEP 2: Click on the tab called "Waivers" where you will then be prompted with the message about signing a waiver for Defy Florence KY. As long as the prompt indicates you are signing for the Florence, KY, location, you may click on "Continue to Waiver."



STEP 3: You will be prompted to enter an email address to complete the waiver for your student. Please note, you must be an adult, 18 years or older.



STEP 4: Here you will complete the form with the required information. This is **YOUR** information first and you will click "Yes" at the bottom indicating you need to complete a waiver for a minor or dependent, your student. You will then see additional fields open (last box) where you will complete the required information for your student. If you have more than one student attending the field trip to Defy, please click "Add another minor" and complete the required information for your additional student(s). Once all information is completed, you will click on "Continue."
